Chairman Paul Kermicle called the special meeting to order.

Monte Newlin administered the Oath of Office to re-elected board member Robert Fear.

A motion to approve the minutes of the May 16, 2011 re-organizational meeting was made by Bob Harris, second by Ron Janes. All were in favor.

Hearing Officer Monte Newlin presided over the hearing.

The petition to be heard was to detach territory from Jasper County Community Unit School District #1 and annex territory to East Richland Community Unit School District #1 submitted by Tedford Farms, Timothy Tedford, President, and Timothy R. Tedford, Trustee per Trust Agreement dated 9/14/2001.

All present were given the opportunity to present testimony. Those presenting testimony at the hearing were Timothy Tedford, petitioner; Dan Cox, Superintendent of Jasper County Community Unit #1 School District and Marilyn Holt Superintendent of East Richland Community Unit #1 School District.

Using case law and school code, the board considered testimony and the exhibits presented. Following consideration by the board a roll call vote was taken. Board members were instructed that a yes vote indicated they approved to grant the petition; a no vote indicated they did not approve to grant the petition.
