The Regional Board of School Trustees held a regular meeting at 7:00 p.m. on July 11, 2016, in the Small Courtroom on the Third Floor of the Courthouse in Olney, Illinois.

Chairman Bill Staser called the meeting to order.

Kaye Holscher made a motion to approve the minutes from the previous meeting, second by Bob Harris. Roll call vote in favor four (4) (Staser, Harris, Holscher, Farley), zero (0) opposed, and two (2) absent, (Allen, Michels)

Bob Harris informed the Board that Todd Hoagland was present at the meeting. He is considering running for the Board.

A motion was made by Kaye Holscher to appoint Julie New to the Regional Board of School Trustees vacancy resulting from Josh Weger's resignation. Bob Harris seconded the motion. A roll call vote of those in favor of the appointment resulted in four (4) in favor (Staser, Harris, Holscher, Farley), zero (0) opposed, and two (2) absent (Allen, Michels). Monte Newlin administered the oath of office and Julie New was seated on the board.

Hearing Officer Monte Newlin presided over the petition hearing. The petition to be heard was to detach territory from North Clay CUSD #25 and annex same territory to Flora CUSD #35 submitted by Jeremy Wildbur and Kelli Wildbur.

All present were given the opportunity to present testimony. The petitioners were represented by Attorney Joel Powless. Those presenting testimony at the hearing were Jeremy Wildbur.

North Clay CUSD #25 was not represented at the Hearing.

A motion to approve the petition was made by Kaye Holscher, seconded by Bob Harris. Using case law and School Code, the Board considered testimony and the exhibits presented. Following consideration by the Board a roll call vote was taken. Board members were instructed that a yes vote indicated they approved granting the petition; a no vote indicated they did not approve granting the petition.




